#### (B) general nature of the dispute

1. Having ascertained the absence of an arbitration agreement (compromissory clause or submission to arbitration), in other words the absence of any reference to the Rules of the Milan National and International Chamber of Arbitration for the Trading of Hides, Skins and Leather, a proposal for arbitration is hereby formulated pursuant to Art. 1.3 of the Rules.
2. Indication of the respondent's details (name, surname, domicile, Tax Code no., telephone no., e-mail address, if the respondent is a natural person; company name, registered offices, VAT no., Tax Code no., telephone no., e-mail address, certified e-mail address, if the respondent is a legal person).
3. Description of the dispute.
4. Indication of the relief sought and its relative economic value.
5. Indication, if any, of the evidence requested in support of the claim and any documentation that the party deems it useful to produce.
6. Indications, if any, of the law and regulations applicable to the merits of the dispute, or to a decision to be based on the principle of equity, of the venue and the language in which arbitration is to be held.

### HAVING SET OUT THE ABOVE

#### The claimant (A)

#### FORMULATES

this arbitration proposal pursuant to Art. 1.3 of the Arbitration Rules of Milan National and International Chamber of Arbitration for the Trading of Hides, Skins and Leather, inviting the counterparty \_\_\_\_\_ with head office in \_\_\_\_\_ to adhere to the same within the term which shall be established by the Secretary General.

Claimant also submits a petition to the Appointments Commission requesting it, pursuant to the arbitration agreement, to appoint the third arbitrator with the role of President of the Arbitration Tribunal.

Pursuant to Art. 14.4 of the Arbitration Rules, Mr./Ms \_\_\_\_\_, Tax Code \_\_\_\_\_ with offices in \_\_\_\_\_ (address, telephone no., e-mail address, certified e-mail address, fax), submitting a petition to the National and International Chamber of Arbitration for the Trading of Hides, Skins and Leather to invite the respondent to appoint his/her/its own arbitrator upon filing the brief of defence, giving notice that in the event of failure to appoint an arbitrator, the arbitrator shall be appointed by the Appointments Commission. Claimant expressly confers upon his/her/its arbitrator the power to proceed, by mutual agreement with the arbitrator appointed by the respondent, to appoint the third arbitrator, who shall take on the role of President of the Arbitration Tribunal. Should the arbitrators thus appointed fail to do so, within the term indicated by the parties or, failing that, established by the Secretary General, the President of the Arbitration Tribunal is appointed by the Designation Commission.

**REQUESTS**
